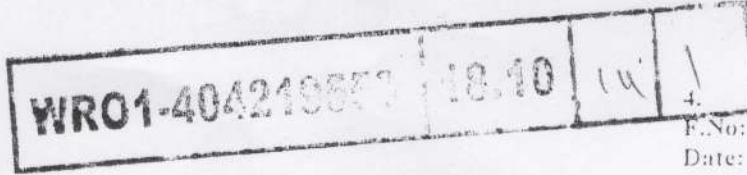

It shall be desirable for the private unaided institutions to induct at least 50% of the members of the Governing Body drawn from renowned academia, academic administrators, Subject Experts and professionals from industry, in order to seek their innovative ideas for continuous improvement in the delivery of teaching learning process, matching best practices elsewhere and achieve excellence.

In exercise of power conferred under 10(p) of the AICTE Act, AICTE, may inspect the institution at any time, if it may deem fit to verify the progress / compliance or for any other purpose.

All reported improvements, endorsed, herewith, should be complied with before the commencement of the next academic year, failing which appropriate action may be initiated.
